A motion was made to approve the previous meeting minutes by Jim seconded by Zach. Motion passed unanimously.

### **President's Report**

**Traphouses/traps:** Traphouses/traps on banks 1-4 and possibly 5 need replaced or repaired, i.e. repainted and/or remortered. This will be looked into after the Westy Hogans. Repairs will handled in house. Steel springs and covers will be looked into for each bank. Bank 11 already has the springs.

**Additional revenue through targets:** Discussion on how to throw more targets. Ideas included: open up early for practice, 50 target non-registered shoots, Annie Oakley or back up events, 50 bird shoot while waiting for the numbers to be drawn on Krieghoff Day. Time restraints might be an issue. Possibly separate shoot for AIM and SCPT instead of holding it at the Colonial. Open up informational session for parents to understand the process. Look into arcade trailer for kids. On Monday and Tuesday of the state shoot, possibly provide sporting clays, zz bird, 5 stand.

**Additional revenue through other venues:** Discussion on the possibility of hosting clinics for extra income. Rent parking lots for food truck events, beer and wine festivals, flea markets, etc. T-shirt and other merch sales at events.

**Equipment needs:** We need a new or used tractor to replace the blue one with front end loader. Also need a new or used fork lift with rubber tires.

**Building improvements:** Moisture problem in hall of fame room. Jim, Steve and Andy Sukel will take a further look at it.

**Telcomm:** Revamp website. Jeff is still the owner of the current website and is willing to sign ownership over to PSSA. Microsoft Teams will be used for correspondence. Steve will get it set up for use.

### **Financial report**

Steve report we are hopeful to be in the black at the end of the year. (see attached report)

Steve Miller will have an extra 500 tickets printed for the drawing during the Eastern Zone.

EC needs to schedule the annual meeting with the Valley Gun Club during the Zone Shoot.

Don moved to adjourn, Zach seconded. Motion carried.
